

## **We are always conscious and respectful of your personal privacy.**

This Privacy Policy governs the use of the International Motor Sports Association, LLC (“**Company**”) website located at IMSA.com (including its sub-domains) and associated applications (such as mobile and other device applications) and other associated offerings that are owned, offered or operated by or on behalf of Company (or its parent or affiliated entities) (“**Site**”). The Privacy Policy’s purpose is to make you aware of our privacy policy and practices and the way information is collected and used with respect to the Site. To make this notice easy to find, a link to this Privacy Policy is on the homepage of the Site.

This Privacy Policy will answer your questions about the kind of information we collect and how we use it. If we change or update our Privacy Policy, we will post those changes here. By using the Site, you acknowledge you have read this Privacy Policy and agree to the terms hereof.

## **What information do you gather and how do you use it?**

Company automatically collects certain non-personally identifiable information about your visits to the Site, such as IP address, service provider, browser type, operating system, pages accessed on the Site and the date and time of access to optimize your user experience and enhance your time spent with us online. Company also receives information telling us the site from which you originated.

We use the personally identifiable information you choose to provide to Company to process the transactions and services you request, to provide Company and Company affiliates promotional communications to you, to enable you to participate in sweepstakes and promotions, and to otherwise facilitate your use of the Site.

### **Who do you share my personal information with?**

### **How does this Site use cookies and similar tracking technologies?**

This Site uses cookies, tags, pixels and similar tracking technologies to allow Company to recognize your preference information, remember your Member Login and facilitate effective site administration.

We also use the services of reputable third parties to provide us with data collection, reporting, ad response measurement, and site analytics, as well as to assist with delivery of relevant marketing messages and advertisements. These third parties may view, edit or set their own cookies. We, our third party service providers, advertisers and/or partners may also place web beacons for these third parties. At this time the Site does not recognize automated browser signals regarding tracking mechanisms, which may include "do not track" instructions. ### **How does this Site comply with the Children's Online Privacy Protection Act?**
